

ZONE 7 SHOW  
CONFERENCE CALL - JUNE 11, 2020

The Conference Call was called to order at 8:05 PM, by the Chairperson, Marjorie Moser. Joining the call were: Dorothy Quirk (Secretary), Jane Munn (Treasurer), Karen Albert (New England PHC), Amy Suess (Garden State PHC), Jill Pacelli (Empire State PHC).

MINUTES: The Secretary read the minutes of the previous May 7, 2020, call. Motion was made (Albert/Munn) and passed that the minutes be accepted as printed and read.

TREASURER'S REPORT: Jane Munn reported the following:

- Balance in the Treasury of \$21,143. Motion was made (Pacelli/Suess) and passed that the Treasurer's report be accepted.
- Jane reported that she has ordered the ribbons for the show at an approximate cost of \$1,200.
- Jane will pay our insurance as soon as Marjorie sends her the information.

COVID WAIVER: We have received the waiver that the Dream Park is requiring each person coming on the grounds at the show to sign. The Dream Park's insurance is requiring this paperwork. The form will be on the Zone website to download.

JUDGES: Marjorie noted that two of our judges reside in Canada and, at this time, the Canadian border is still closed. We will keep in mind that we may need to hire a replacement USA judge.

OFFICE STAFF / PAPERWORK:

- Christine would appreciate as many pre-entries (including stall counts, hook-ups, shavings, Covid forms, etc. as possible.
- Shavings orders must be received prior to the show. They can be ordered by contacting Dorothy Quirk ([dquirk463@gmail.com](mailto:dquirk463@gmail.com)). Shavings will be delivered to the barn, but not to the stalls, once the show opens.
- Pre-entry information - including mailing information, will be found on the Zone Show website.

SHOW SPONSORS: Amy Suess reported that Sponsorship information will be noted on the Zone Show website and Facebook page. She is asking everyone to help her with obtaining sponsorships.

ZONE 7 WEBSITE: Corporate sponsors will receive prominent recognition on the Zone website. Business cards will also be noted.
